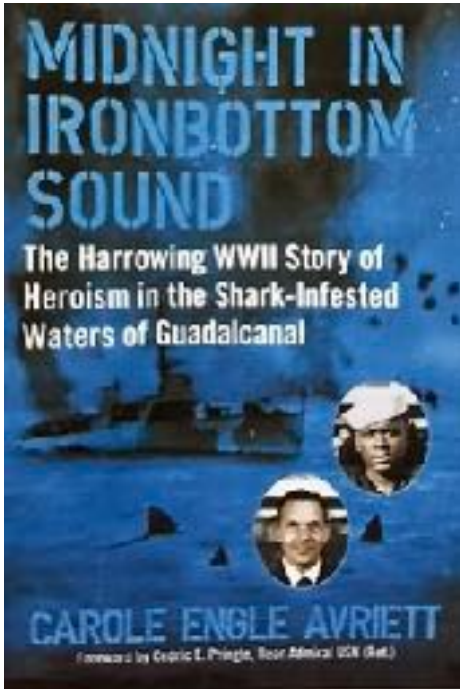


This month we will be visited again by author Carole Engle Avriett who will discuss her latest book "Midnight in Ironbottom Sound" which tells about the harrowing story of heroism in the shark-infested waters of Guadalcanal. She will be joined by RAdm Cedric E. Pringle, USN (Ret.) who wrote the forward to her book. They both spoke at the WWII History Book Club a couple of months back and were very well received. Both are good speakers and the story is amazing.



Cedric E. Pringle Bio

Cedric Pringle is a retired rear admiral following a 34-and-a-half-year career in the U.S. Navy. His service culminated as the 31st commandant of National War College at National Defense University. During his distinguished career, he led joint, combined, multinational, and interagency organizations, both at sea and



ashore, across all aspects of defense, including full spectrum operations, strategic planning, crisis management, and congressional affairs. Among his numerous assignments, he commanded Expeditionary Strike Group 3, the Navy's largest Strike Group, that is composed of 15 ships, 31 subordinate commands, and 15,000 Sailors and Marines. Prior to his selection as a flag officer, he commanded the Navy's first hybrid propulsion drive ship, USS Makin Island (LHD 8), earning multiple awards for operational and leadership excellence, as well as the President's Volunteer Service Award for community outreach. Additionally, he served as Director of the Navy's Senate Liaison office where he facilitated enduring relationships between Department of Navy leaders, U.S. Senators, and key Senate staff members. A proven leader during crisis responses, he commanded the USS Whidbey Island (LSD 41) during Hurricane Katrina Disaster Relief in 2005 and served as the commander of Joint Task Force Matthew, leading relief and recovery efforts in Haiti following Hurricane Matthew, in 2016. Admiral Pringle earned a B.S. in Economics from the University of South Carolina, an M.S. in Financial Management from the Naval Postgraduate School, and an M.A. in National Security Strategy from the Naval War

College. He serves as the 25th President of the National Naval Officers Association (NNOA), an organization founded in 1972 to support the Sea Services in recruiting, professional development, and retention of a diverse officer corps that reflects the demographics of our nation.

2025 17th Annual Military Charities Golf Tournament



Our 17th annual tournament is now behind us and we can finally slow down a little. The tournament went well and we had a number of twists and turns this year which is basically what I have come to expect when putting on a tournament like ours. As you already know if you have been faithfully reading the newsletter, we hope to raise \$30,000 from the tournament each year in order to fund the scholarships (\$15,000) we give each year (\$1,500 and \$1,000 to the top two senior cadets from each of the six high school JROTC units in our two county catchment area) and an equal amount (\$15,000) to donate to the eight area military oriented charities we support. Last year we did quite well and earned \$33,000 from the tournament and so we were able to increase the amount of donations to the charities. This year was even better. Although the final figures are not finalized, it looks like we raised \$36,000 this year and so we anticipate raising the scholarships to \$2,000 and \$1,500. Our Board of Directors will make the final decision on May 6th. There are a number of reasons for our success this year but the main reason was the largess of the **Blackston Financial Advisory Group** who became our main corporate sponsor for the tournament. We were also very fortunate to have the Suleiman Family Restaurants give us a certificate for one free meal a week for 52 weeks worth \$1,300. We put the certificate in a raffle and raised \$5,000 for the tournament. Although we lost a handful of Hole Sponsors (\$500 or more) from last year, our Golf Committee did a great job in locating other Hole Sponsors to take their place. Altogether, we had 24 Hole/Major Sponsors and received a total of \$22,700 from our sponsors. We raised \$1325 from our Remembrance Signs and \$1550 from our Club and Commercial signage. The tournament itself raised \$5,030 (after expenses) from the golfers, mulligans, putting contest, 50-50, silent auction and live auction. To top it off, a number of our winners donated their winnings (\$982) back for use in scholarships and charity donations. Really outstanding contributions. We currently have 286 Chapter members. All Chapter members are also members of National MOAA!!

Thought I'd resend information about expiring DoD ID cards in case some of you might be traveling away from The Villages and need/want to visit an ID card facility at/close to your destination. This may help.

As you know, I checked with the DMDC folks. Our old blue retiree ID cards are of two types, one with a social security number and one with a DoD ID number. Both will expire in 2026. No specific date/month was provided, so I'd assume 31 December 2025 for the time being.

There are two ways to renew/replace your ID card: **in person** and **online**.

- (This first way may be helpful to those of you that may be traveling.) For **in person** service, the best way is to make an appointment. You can do this online at: <https://idco.dmdc.osd.mil/idco>. Click on "ID Card Office Locator & Appointments", put in your zip code of where you are/will be, select 100-mile radius. You can select appointments, walk-ins or both. Then click on "Search". This will bring up a map with multiple places along with addresses and phone numbers. Select the location you desire and follow the prompts.
- For **online service**, go to the above website and then select "Family ID Cards". Your picture in DEERS must not be older than 12 years. You will need a DS LOGON account. If you do not have one, select "Create New Account" and follow the prompts. You will need to know your unique email address in DEERS. Once logged in, follow the prompts to get your new ID card mailed to you.

MOAA's Advocacy in Action Campaign— Status Update



On April 9th, MOAA staff, Board members and more than 150 volunteers from Chapters and Councils took to Capitol Hill in Washington, D.C., for Advocacy in Action 2025, meeting with over 330 targeted congressional offices. Together, they delivered a unified message: ***Congress must do all that it can to protect service-earned pay and benefits.***

Incentivize Military Spouse Hiring: Actions to combat stagnant, high rates of unemployment among military spouses must include measures to incentivize their hiring. Cosponsor the Military Spouse Hiring Act to add a military spouse target group to the Work Opportunity Tax Credit program.

Unaccompanied Housing Improvements: Transparency is key to supporting lawmaker oversight of this ongoing issue and addressing a \$137 billion maintenance backlog. Ask Congress to require DoD to make reports on unaccompanied housing installation conditions publicly available.

Ending the Wait for Toxic-Exposed Veterans: Pass legislation to shorten how long millions of veterans must wait before receiving service-earned care and benefits.

Support Veteran Caregivers: Champion/cosponsor the passage of the Veteran Caregiver Reeducation, Reemployment, and Retirement Act.



The 119th Congress is just getting started, and our lawmakers need to keep hearing from their constituents on the issues that matter to the military community. The work our Florida team did on Capitol Hill must be reinforced by advocates in the chapters back home. The campaign is far from over, and likely will be contentious. The pressures on service-earned pay and benefits aren't going away.

We need every voice and every advocate to remind Congress that the greatest asset to our nation's security and prosperity is not a weapon system — ***it's the men and women in uniform and their families.***

MOAA is asking each of us to “*Reach out with Tailored Communication*” to emphasize the need for congressional legislative action.

“An effective approach — particularly for issues that impact you personally or you feel especially passionate about — is to **send a more personalized message to your representatives.**”

A well-crafted email providing background on your service, highlighting MOAA advocacy priorities, and offering your perspective as a constituent can make a significant impact. **Personal engagement sends a strong message that military issues matter to voters in the district.**

To connect with your lawmakers, visit their website and click the “contact” tab. You can also call MOAA's toll-free line to the U.S. Capitol switchboard at (866) 272-MOAA (6622) and to speak with the lawmaker's office.”

Major Richard Star Act Re-Introduced in the 119th Congress

For the fourth time in the past seven years the Major Richard Start Act has been re-introduced to authorize combat-injured veterans to receive their earned DoD retirement pay for years of service and their VA disability compensation for lifelong injury. Currently, these combat-injured (and often seriously disabled) veterans are subject to a cost-saving offset where their retirement pay is reduced for every dollar of VA disability received. To reduce earned retirement pay because of a combat disability is an injustice; the compensation for these injured veterans is not the place to achieve savings.

Already 14 Florida representatives have signed on as co-sponsors. Check here to see who is on the list

State Legislative Update

STATE LEGISLATIVE UPDATE

The Florida legislative session is at the halfway point with many bills awaiting consideration. The following bills are in addition to those reported in the last newsletter. The property tax exemption bills have shown little progress.

***SB 0290 Property Tax Exemption for Surviving Spouses of Veterans. Property Tax Exemption for Surviving Spouses of Veterans; . Effective Date: 7/1/2025

Referred to Community Affairs; Finance and Tax; Appropriations

***HB 0313 Toll Exemptions for Purple Heart Medal Recipients .Toll Exemptions for Purple Heart Medal Recipients: Revises eligibility for toll exemptions to include

operators displaying Purple Heart specialty license plate or Purple Heart special motorcycle license plate. Effective Date: July 1, 2025

***HB 0821 Business Development Incentives for Veterans and Military Spouses.

Requires DOS to waive specified fees for certain businesses established by veteran or military spouse; provides eligibility & registration requirements; Effective Date: July 1, 2025

***SB 0402 . Unlawful Use of Uniforms, Medals, or Insignia; Prohibiting persons from wearing the uniform of or any medal or insignia authorized for use by members or veterans of the Space Force, etc. Effective Date: 10/1/2025

***SB 1016 Increased Homestead Property Exemptions; Proposing an amendment to the State Constitution to increase the homestead exemption from \$25,000 to \$75,000, for all levies, with annual adjustments for inflation, deleting the exemption for school district levies, etc.

***SB 1172 Preferences for Veterans and Military Spouses; Requiring the state and its political subdivisions to give preference in appointment and retention in positions of employment to the spouses of war-time veterans, veterans, members of any reserve component of the United States Armed Forces or the Florida National Guard,

***HB 555 Exempts veterans from paying the \$75 fee for a medical marijuana card.

IMPORTANT MESSAGE

MOAA's status as a tax-exempt veterans organization precludes it from participating in political activities, which are defined as intervening directly or indirectly in any political campaign on behalf of or in opposition to any candidate for public office. We all need to be particularly attentive to this *non-partisanship restriction* during this very active political campaign season, when we are wearing our MOAA hat either individually or on behalf of our Chapters.

MOAA is a registered **lobbyist** with Congress. This legal designation pertains to the nature of communications with elected officials and staff. Maybe a better term to describe their effort is **advocacy**:

the association does play an active role in the field of military personnel matters and especially proposed legislation affecting the career force, the retired community, and veterans of the uniformed services and advocates for a strong national defense it does not, as an association, become involved in matters pertaining to military strategy or individual weapons systems of the various services. The association believes that such decisions can be made only by those who have all of the facts available to them: today's actively serving military leadership.

MOAA has been recognized for the past 18 years by **The Hill News** as a TOP Lobbying Organization based on its effective advocacy on the issues defined in its governing documents and resolutions, presenting and supporting legislative proposals that provide for the fair and equitable treatment of members of the Armed Forces, including the National Guard and Reserves, military retirees, family members, survivors, and veterans as defined in its federal Charter in 36 USC, chapter 1404.

The Editorial Policy of this Newsletter is consistent with the discussion above.

Editorial Policy

MOAA is the nation's largest and most influential association of military officers. It is an independent, nonprofit, politically nonpartisan organization. May is Military Appreciation Month

May 1: Loyalty Day

Loyalty Day is as simple as it sounds: a day set aside for U.S. citizens to reaffirm their loyalty to their country and to remember their heritage. It was started in 1921 and a few communities still celebrate with parades and other ceremonies. It is a legal holiday, but not federal in nature.

May 5 – May 11: Public Service Recognition Week

Traditionally celebrated during the first full week of May, Public Service Recognition Week honors the individuals who serve as federal, state, country, and local government employees. It is not commonly celebrated, but it is sometimes used to educate the public about the contribution of government workers.

May 8: Victory in Europe Day

The unconditional surrender of Germany in World War II came on May 8th, 1945. Sweeping celebrations seized Chicago, Los Angeles, Miami, and New York City.

May 12: Military Spouse Appreciation Day

Celebrated the Friday before Mother's Day, [Military Spouse Appreciation Day](#) celebrates the sacrifice and support of military spouses. The holiday began in 1984 under Ronald Reagan, and subsequent presidents have begun the day with speeches or proclamations. "They also serve who only stand and wait" – the last line of Sonnet XIX, John Milton, 1652

May 20: Armed Forces Day

Celebrated on the third Saturday of every May, [Armed Forces Day](#) honors Americans serving in the military. It was originally designed to replace the days celebrating each individual service, but those days are still observed. The longest running celebration sponsored by a city is held in Bremerton, Washington. 2012 marked its 64th celebration with a parade.

May 30: Memorial Day

Landing on the final Monday of May, [Memorial Day](#) is the most widely recognized holiday out of the May military-themed observances. It began after the Civil War to remember the soldiers who fell on both sides during the war, but grew to commemorate all Americans who died serving in the military
