


## Presidents Message

As we start our summer hiatus, I want to thank all of our volunteers on our Golf Committee for their superb work this year in helping put on our best golf tournament in many years. Our last speaker this Spring was author Carole Engle Avriett who spoke about her latest book "Midnight in Ironbottom Sound," the story about the sinking of APD-3 U.S.S. Gregory off of Guadalcanal on 4/5 September, 1942, and the heroic events that followed. The Gregory was a WWI era destroyer converted to a high speed transport for Marine Raider units. Carole has spoken to us about her books three times previously: Jan. 2018 "Under The Cover Of Light;" Jan. 2019 "Coffin Corner Boys;" and Jan. 2022 "Marine Raiders." She was accompanied by RAdm. Cedric E. Pringle, USN (Ret.), who wrote the forward to her book and who commanded the U.S.S. Makin Island (LDH-8), a Wasp-class amphibious assault ship named for the target of the Marine Raiders' Makin Island raid early in WWII in which the Gregory participated.



## Chaplain's Corner

As we mark the 81st anniversary of D-Day, we reflect on the profound spiritual lessons embedded in this pivotal moment of history. The Normandy landing exemplifies sacred sacrifice, with soldiers laying down their lives for the freedom of others. As Jesus taught in Christian scripture, "Greater love has no one than this: to lay down one's life for one's friends" (John 15:13)—a principle echoed across faith traditions that honor selfless service. As retired officers who have served with distinction, you understand this timeless principle of sacrifice in a deeply personal way.

The courage displayed on those beaches reflects the faith that sustains us in our darkest hours. The Psalmist wrote, "The Lord is my strength and my shield; my heart trusts in him, and he helps me" (Psalm 28:7), while people of many faiths find similar comfort in divine providence during times of trial. Your military careers required this same courage and faith, virtues that continue to guide you in retirement and community service.

D-Day united men from different religious backgrounds, denominations, nations, and cultures in common purpose against tyranny. While Christian scripture reminds believers that we are "all one in Christ Jesus" (Galatians 3:28), this unity across differences is a principle honored by all major faith traditions. Your MOAA chapter embodies this unity of purpose, bringing together officers from various backgrounds in fellowship and shared mission.

Despite overwhelming obstacles, the Allied forces persevered, embodying the perseverance described in many religious texts. The Apostle Paul encourages, "Let us not become weary in doing good, for at the proper time we will reap a harvest if we do not give up" (Galatians 6:9). As veterans who built distinguished careers through steadfastness, you understand that meaningful achievement requires endurance through difficult seasons.

This solemn anniversary calls us to remember and honor those who came before us, a principle woven throughout religious traditions worldwide as communities are instructed to remember righteous deeds and faithful servants. As senior members of the military community, you are entrusted with preserving and passing on this legacy of faith-filled service.

Though your uniforms have been set aside, your calling as leaders guided by spiritual principles continues. The legacy of D-Day challenges us to live with purpose, sacrificial service, and unwavering courage shown on those distant shores eight decades ago. In the words of Scripture that speak to many, may you continue to "fight the good fight, finish the race, and keep the faith" (2 Timothy 4:7).

## MOAA's Advocacy in Action Campaign— Status Update



### National Defense Authorization Act Lags Behind Congresses Legislative Schedule

The Senate Armed Services Committee has just started working on the FY2026 National Defense Authorization Bill. That draft version contains the vast majority of the quality-of-life funding boosts found in the [House-passed version](#), to include support for several key MOAA quality-of-life priorities.



*“While many portions of this bill are pointing in the right direction for servicemembers, retirees, veterans, and their families, **the final result is far from certain**,”* said Maj. Gen. April Vogel, USAF (Ret), MOAA’s vice president of Government Relations. *“As the process moves forward, there will be opportunities to ensure MOAA priorities remain at the top of the to-do list for lawmakers – and we’ll need help from our members, and others, to make that happen.”*

Key provisions include:

**Better BAH:** \$2.9 billion to raise the Basic Allowance for Housing (BAH) to 100% of anticipated housing costs. This would restore the cuts made in 2015, when Congress began a series of annual decreases before reaching the current 95% level in 2019.

**Housing Help:** More than \$1.2 billion earmarked for housing modernization and sustainment, to include more than \$230 million for Marine Corps barracks improvements.

**Spouse and Family Support:** \$100 million in child care fee assistance, on top of the \$62 million in DoD staffing funds not found in the House version. Another \$100 million for Impact Aid payments (designed to assist school districts with large DoD populations), and \$10 million for military spouse professional licensure.

**Health Care Assistance:** \$2 billion in additional funding for the Defense Health Program.

The Senate version must be reconciled with the House version and passed by both Chambers before the 30th of September, which is sooner than it looks with the 8 weeks of recesses on the calendar between now and then.

In addition to this most important legislation there are currently 25 bills across the House and Senate introduced in the 119<sup>th</sup> Congress that can be found on the **MOAA – Supported Legislation** page at this link [MOAA | Action Center](#) .

One of the Bills on that list is **The Major Richard Star Act HR-2012 and S-1032**. On May 21<sup>st</sup>, combat-injured veterans, legislators, and representatives from MOAA and other

veterans advocacy groups conducted a press event on Capitol Hill to continue their advocacy work aimed at ending an unjust offset faced by tens of thousands who are forced to give up a dollar of their earned retirement pay for every dollar of VA disability pay received.

This bipartisan bill with more than 340 co-sponsors. has yet to cross the finish line, either as a stand-alone measure or as part of the annual National Defense Authorization Act (NDAA). ***Despite similar levels of support in previous congressional sessions, House leadership has failed to advance the bill for a vote.*** MOAA's Calls-to-Action over the past three congresses have resulted in the largest count of messages from our members sent on any matter before the legislature. Ask your Representatives and Senators why they are ***failing on our country's promise to take care of those injured in service ...*** their co-sponsorship rings hollow to those families who are not receiving the compensation due them. ### **A Personal Note from Bob**

You may have read in last month's *Officers Call* that I was selected for the 2024 Colonel. Steve Strobridge Award for the Council Legislative Chair/Liaison. Legislative Advocacy has continued to be my major focus in the various roles I filled in MOAA Chapters and Councils going back to 2005 when I first met Steve Strobridge at a New York Council Convention. I had the pleasure on many subsequent State, Regional, and National meetings to renew our acquaintance and worked directly with him on several campaigns. That relationship grew with his successors as Directors and VPs of Government Relations and many of the staff. I was proud to represent the members and Chapters in two Councils (New York and Florida) in my exchanges with our National Team.

That may have been the factor that led to this award – I never presented myself as “THE” advocate in those organizations but as a promotor of the grassroots efforts and liaison with our elected representatives and their staffs. I would add that one measure of my efforts has been the record of advocacy messages by the members of this chapter and the chapter leaders in the Florida Council - our count of messages sent in response to MOAA's Calls-to-Action have been consistently the highest across all the states. **We all share in that accomplishment – thank you for that**

### IMPORTANT MESSAGE

MOAA's status as a tax-exempt veterans organization precludes it from participating in political activities, which are defined as intervening directly or indirectly in any political campaign on behalf of or in opposition to any candidate for public office. We all need to be particularly attentive to this *non-partisanship restriction* during this very active political campaign season, when we are wearing our MOAA hat either individually or on behalf of our Chapters.

MOAA is a registered **lobbyist** with Congress. This legal designation pertains to the nature of communications with elected officials and staff. Maybe a better term to describe their effort is **advocacy**:

the association does play an active role in the field of military personnel matters and especially proposed legislation affecting the career force, the retired community, and veterans of the uniformed services and advocates for a strong national defense it does not, as an association, become involved in matters pertaining to military strategy or individual weapons systems of the various services. The association believes that such decisions can be made only by those who have all of the facts available to them: today's actively serving military leadership.

MOAA has been recognized for the past 18 years by **The Hill News** as a TOP Lobbying Organization based on its effective advocacy on the issues defined in its governing documents and resolutions, presenting and supporting legislative proposals that provide for the fair and equitable treatment of members of the Armed Forces, including the National Guard and Reserves, military retirees, family members, survivors, and veterans as defined in its federal Charter in 36 USC, chapter 1404.
